WASTE DEPOSIT GREEN, YELLOW AND RED BAG



☀ **SUMMER SCHEDULE: 1.5.–30.9.**

Every day from 10 PM until 7 AM

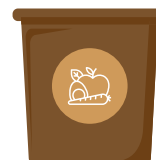
❄ **WINTER SCHEDULE: 1.10.–30.4.**

Every day except Sunday from 9 PM until 7 AM

The waste is to be deposited in the appropriate bags **in front of your own door** and not in front of your neighbour's door!

DO NOT deposit the waste after 7 AM.

☀ **SUMMER SCHEDULE: 1.5.–30.9.**

Every day from 6 PM until 8 PM

❄ **WINTER SCHEDULE: 1.10.–30.4.**

Every day except Sunday from 6 PM until 8 PM

The kitchen waste is to be deposited **in a brown container**, tightly tied up in an degradable bag.

DO NOT deposit the waste after 8 PM.

USE THE APPROPRIATE BAG

- **GREEN:** non-recyclable material, dirty foodstuff packaging, cigarette butts, ashes, large bones, sweeping waste, vacuum-cleaner bags, litter tray sand, nappies, ...
- **YELLOW:** plastic, metal and Tetra Pak materials, empty, pressed, no cork.
- **RED:** clean paper, paper and cardboard material, disassembled and attened.
- **BIODEGRADABLE BAG:** leavings and peelings of fruit and vegetables, deteriorated food, coffee dregs and filters, bones and sh bones, tea and tea bags, eggshell, leavings of food.

Glass is to be deposited at the recycling centres.

Bulky waste: free transport up to 5m³ a year (2x a Jolly vehicle) on basis of an order in advance by phone +386 (0)5 617 50 79 or e-mail: info@okoljepiran.si and filled in form acquirable in our offices or at our website.

Occasional visitors and inhabitants of Piran, and those who leave Piran before 6 PM or 9 PM **can deposit their waste at the 5 recycling centres on exiting of the old town: at the main bus station on Dantejeva Street, at the town walls (IX-Corpus Street), on the Rozmanova Street, on the Oljčna Street and on Punta.**

The bags can be obtained at our office on the Savudrija Street 13.

The bags are free of charge on presenting the waste BON and must be picked up **every month** or at least within one year.

The fine for the inappropriate waste disposal or avoiding the waste management payment is 2,000.00 € for a legal person and 400.00 € for the responsible person within the company. The household not registered for the waste management system a fine is to 400.00 €, other violations of this act are fined with 200.00 €.
